

Call to Order: A regular meeting of the State Board of the AFNYST was held at 916 Riverside, 916 County Rd 37, Central Square, NY 13036. The meeting convened at 12:16 P.M, President Michael Doney presiding, and was opened with the Pledge of Allegiance, followed by a moment of silence for our departed Members. (the meeting was temporarily adjourned for lunch at 12:45 PM and resumed at 1:12 PM)

Reading and Approval of Minutes: Motion to waive the reading of and approve the minutes of the November 13, 2021 was made and seconded. **Motion carried**.

Officer's Reports:

President Doney: Reported that he was invited to represent the Association at the

annual Superintendent's Awards ceremony at the Academy.

Vice-President: Reported that Dennis Spanitz has stepped down as the Batavia Chapter Treasurer due to health reasons and that the Chapter wants to transfer the position to Associate Member Kathy Hartman. **(see New Business below)**

Treasurer: Absent. President Doney read out the Treasurer's report. A question was asked about the Life Member savings account (no answer known). A question was asked about the FARTS reunion ad and the possibility of FARTS becoming an official Chapter. Fred Scheidt stated that this did come up at the reunion in March and Mike Doney advised this has come up in the past. A motion was made and seconded to accept the Treasurer's report. **Motion carried.**

Secretary: Nothing to report.

PBA Retiree Delegate:

- Retirement COLA Several retiree groups are working on increasing the COLA calculation.
- Alex Dell, an attorney specializing in WTC 9/11, workers comp and retiree issues has
 offered to present to the board at a future meeting.
- Question was asked about the PBA Variable Fund: One had to have been represented by the PBA from 2007-2011, the period in which the contracted physical fitness monies were given to the PBA and invested.
- A comment was made that members who took the ½ retirement option discovered that any popup, ½ option, etc is based on the original pension amount at retirement, not the amount after any COLA increases. Fred talked about proposing a tiered COLA system for larger COLA's to retirees with lower pensions. He also noted that our insurance copays increase with the active duty contracts but the COLA does not align with the same contracts.

Board and Committee Reports None.

Old Business: <u>Fund to Assist Retired Members</u> 09/18/2021 Charlie Simmons (CD Chapter) presented an idea of establishing a fund that would assist retired Troopers and their families in a time of need.

11/13/2021 Terry Sutton (Niagara Chapter) advised that the Helping Hands organization met and decided to keep their organization tied to the AFNYST Niagara Chapter and not to expand the statewide AFNYST. Discussion centered on seeking to form a separate fund or exploring the option of expanding retiree access to Signal 30 funds. It was noted that PBA Liaison Fred Scheidt was actively pursuing this with the PBA Board. No motions were made on the matter at this time. **Carried over.**

04/16/2022 PBA Delegate Fred Scheidt advised that the PBA is planning on moving forward with a Signal 30 style fund for retirees. This was discussed at the FRATS reunion by PBA Officer Delegate Dan Charleson.

More info to follow. No motion to reopen. Carried over.

New Business: <u>Chapter Officers/Associate Members</u> VP Louis Lang reported that Dennis Spanitz has stepped down as the Batavia Chapter Treasurer due to health reasons and that the Chapter wants to transfer the position to Associate Member Kathy Hartman. Louis acknowledged that Associate Members are not allowed to vote and that the Batavia Chapter wanted to explore changing the rules to allow them to vote. He noted that it is becoming difficult to get new members. President Doney stated that the Association bylaws require Chapter officers to be regular Members. His personal belief is that Kathy Hartman would do a fine job as treasurer. Discussion centered on allowing Chapters to decide on their own the roles of Associates. **No motion made at this time.**

[Secretary Note: The relevant sections of the AFNYST Constitution are:

Article 3. Membership

Section 1. Membership in the Association of Former New York State Troopers, Inc., shall include: (1) Regular Members, (2) Honorary members and (3) Life members, who shall possess the necessary requirements.

Section 3. Honorary members may attend meetings and be permitted to speak, but may not purpose motions, vote or preside. The holding of an Honorary Membership shall not preclude a person who is a Regular Member from holding an office at the Association or Chapter level and/or otherwise performing and participating as a regular member.

Section 6. All applications for Honorary Membership and Life Membership shall be considered and conferred by the Board, and which shall at any regular meeting require a majority approval of the Board. Chapters shall forward applications for Chaplains and those above to the Board consideration and approval. Likewise applications for Life Membership shall also be forwarded to the Board by Chapters for consideration and approval. All such applications shall be accompanied with a résumé supporting the named applicant along with pertinent data.

Article 6. Nominations and Election of Association and Chapter Officers

Section 1. All members in good standing shall be eligible to hold office in the Association or its Chapters for not less than two (2) years. The Election shall be determined by popular vote of the valid ballots received.

Section 8. A vacancy in the Office of President of the Chapter shall be filled by the Vice-President. A vacancy in any other office shall be filled by the Chapter President, with the majority of other Chapter Officers, and the members so appointed shall fill out the unexpired term of the Office made vacant.]

Good and Welfare: Mike Doney asked if anyone knew of the status of Trooper Christopher Baldner and his criminal case.

Next Meeting: The next meeting will be held at 12:00 PM on Saturday, June 18, 2022 at 916 Riverside, 916 County Rd 37, Central Square, NY 13036.

Trooper is on a Remarkable Journey (edited and reproduced)

It was a thrilling day for the Capitano family of Sheridan when their son, Guy Capitano II, graduated from the 209th session of the Basic School of the New York State Police Academy on March 18, 2020. While the family could not attend the ceremony in person due to the COVID-19 pandemic, the magnitude of Guy's accomplishment was not lost on them, for nearly 18 years ago, Guy was fighting for his life.

In July 2002, Guy and his father, Guy Sr., were severely burned when their pickup truck caught fire outside of Jamestown. At the age of just six years old, Guy suffered a devastating injury of third-degree burns to 35% of his body. He was treated at the Shriners Burn Care Hospital in Cincinnati, Ohio and, over the years, underwent several surgeries and therapy procedures.

Guy and his father made incredible recoveries from their injuries, and Guy went on to become an honor roll student and athlete at Silver Creek High School. While on the high school football team, Guy developed a passion for fitness. His long-time dream was to join the military; however, he was eventually disqualified due to his extensive medical history. His father joked that "they needed a dolly to transport his files."

Although heartbroken by the Army's rejection, Guy rallied to put his "plan B" into effect. He enrolled in the culinary program at Alfred State University to pursue another passion of his: cooking.

In 2016, he received his Associate of Applied Science degree from Alfred State. He qualified as an applicant for the state trooper program and scored high on the entrance test. During this time, Guy developed an interest in cross-fit training and has since participated in several competitions. He also acquired his personal training certificate and was working in that field when he was called to the Academy. Guy recalled that it was a long wait from the time he received the call until he was actually able to report to the Academy. One class filled up and the next was postponed, and even when he finally entered, there was no guarantee he would

graduate successfully. Many have failed to make it through the physically grueling and mentally taxing six-month training program. Guy was proud to be one of 226 new state troopers who graduated from the New York State Police Academy after 26 weeks of hard work and dedication.

"When my family was burned in 2002, so many people and organizations in the community stepped up and came out to help us recover," Guy said. "I feel honored and privileged to serve the awesome people of New York state."

Trooper Capitano is currently stationed at SP Binghamton in Troop C.

ARE YOU ELIGIBLE FOR SOCIAL SECURITY DISABILITY?

Happy 62nd birthday! You worked hard your whole life to finally achieve this moment – you can now elect to start receiving Social Security retirement benefits from the Social Security Administration (SSA). But wait, even though you can now start collecting Social Security retirement benefits, should you instead wait until you reach your full retirement age so you can obtain a higher monetary benefit for the rest of your life?

What happens if you cannot wait until your full retirement age? Did you consider whether to file for Social Security Disability Insurance (SSDI)? Did you know that if you are approved for SSDI, your monthly Social Security disability benefit would be higher than the monthly benefit you would receive if you started collecting your Social Security retirement before your full retirement age, even if you are approved for SSDI as of or prior to your 62nd birthday? That's right, a SSDI benefit will essentially pay you the equivalent of what you would have received had you waited until your full retirement age to start collecting your Social Security retirement.

The unfortunate reality is that most people are not aware that SSDI can pay you more money per month than a regular Social Security Retirement. For every 100 people who simply elect to take their regular Social Security retirement, it is likely that one-third or more of these individuals may have qualified for SSDI, yet never knew about SSDI or that they might be eligible to apply for disability benefits. Worse yet, these same individuals are permanently giving up the right to receive an additional 25%-30% more money per month for the rest of their lives simply because they elected to start receiving early retirement benefits rather than applying for and receiving Social Security disability benefits. Read on for how you or someone you know can make the best financial decision when it comes to pursuing your Social Security benefits.

Social Security replaces a portion of your pre-retirement income based on your lifetime earnings based on your highest 35 years of earnings. A person's monthly benefit varies depending on your earnings and most importantly when you choose to start receiving such benefit. You can start receiving Social Security at an early retirement age (i.e., 62), your full retirement age (i.e., 66 or 67 depending on when you were born), or at a delayed retirement age (i.e., 70), with no incentive to delay claiming after age 70.

For example, if an individual born in 1960 waited to collect their Social Security retirement until their full retirement age (i.e., 67), such benefit would be \$2,500.00 per month. However, if that same individual took an early Social Security retirement at age 62, such individual would only get \$1,750.00 per month, a whopping \$750.00 loss per month for the rest of their life. Whether someone elects to take their Social Security retirement when they are first eligible (age 62) or waits until their full retirement age (i.e., 66-67) or delays until even later (e.g., age 70) is the subject of endless debate, primarily fueled by predictions about one's life expectancy and financial considerations. And this is exactly why you should be thinking about whether SSDI is the better Social Security benefit for you or someone you know.

Like Social Security retirement, SSDI provides a monthly monetary benefit to people who have a medically determinable impairment that restricts their ability to engage in what is referred to as the ability to engage in substantial gainful activity ("SGA"). For 2022, an individual who is unable to earn at least \$1,350.00 per month (or the equivalent of \$16,200.00 per year) is not considered capable of substantial gainful work activity. Yes, you can still work and be eligible for SSDI.

To be eligible for SSDI, you must file an application with the Social Security Administration, and demonstrate you are either out of work or unable to earn more than \$1,350.00 per month (in 2022); that you have a severe medical condition(s) lasting or expecting to last for at least 12 months; that you cannot do the work you previously performed; and that given your age, education and prior work experience you are incapable of performing other work activity. In certain cases, you may have such a severe medical diagnosis which automatically qualifies you for SSDI benefits. You do not have to be at least 62 years young to apply for SSDI. In fact, many people in their 20s, 30s, 40s and 50s are receiving SSDI benefits.

No matter what your age, it is important to note that unlike Social Security retirement benefits, which require you to have worked long enough, SSDI benefits also require you to have worked recently enough to have earned a certain amount of work credits within the ten years before you became disabled. Generally, you need to have worked at least 5 of the last 10 years before your disability started. So, if you think you might meet the criteria for SSDI now, or at any age before your full retirement age, it is best to apply as soon as you become disabled. Additionally, since SSA can only pay benefits up to a year before your disability filing date, waiting to apply may cause you to miss out on significant retroactive SSDI benefits.

You can receive SSDI in addition to Workers' Compensation, Disability Retirement and Veterans Affairs benefits. In some cases, certain benefits may be reduced by the receipt of other benefits, but such determination must be made on a case-by-case basis to insure such person receives the maximum benefits from multiple sources.

One of the most important reasons to also pursue SSDI is because you will also become eligible for Medicare once you have received the equivalent of 24 months of SSDI benefits, even if you are not age 65. Unless you have end stage renal disease or are 65 years young, you are otherwise not eligible for Medicare.

It is common for people to apply for SSDI and get denied. Do not get discouraged especially if you are truly disabled from substantial gainful work activity. You are permitted to challenge a denial, which may ultimately lead to a hearing before an Administrative Law Judge who will consider all the facts and determine whether you are eligible for SSDI. An attorney can help you navigate this process and potentially lead to a successful application for benefits. An attorney is only paid if your application is successful, and even then, the attorney fee is a one-time fee on any past due benefits you may be owed by the Social Security Administration.

MERCY FLIGHT HELICOPTER CRASH KILLING TWO (reproduced and edited)

ELBA, N.Y. — Colleen Lamie said she was sitting in her bedroom Tuesday afternoon when she heard a disturbing sound behind her house in the Town of Elba — a series of "whoops" and "clicks," then a loud explosion, all within a few seconds. "I thought I could feel the vibration of the boom," she said. It was a Mercy Flight helicopter. It crashed during a training exercise at about 1 p.m. in a field off Norton Road, killing Mercy Flight pilot James E. Sauer, 60, of Churchville, and Stewart M. Dietrick, 60, of Prosper, Texas, a Bell Helicopter employee/pilot. They were pronounced dead at the scene and transported to the Monroe County Medical Examiner's office.

The helicopter had taken off from the Genesee County Airport about four miles away, where Mercy Flight bases some of its aircraft. In a statement, Mercy Flight said the accident occurred during its annual Bell Helicopter factory training. Sauer, a retired New York State Police pilot, began working with Mercy Flight in October 2020.

"It goes without saying that our attention needs to be focused on the families of those lost and on our own employees as we deal with this unspeakable tragedy," Mercy Flight president Margaret Ferrentino said in a statement. "This is a very dark day for the Mercy Flight family, we are so grateful for the expressions of love, concern and support expressed by many."

The National Transportation Safety Board and Federal Aviation Administration are working with state police to determine the cause of the crash north of the intersection of Norton and Edgerton roads, close to Route 262.

Kelley Home Town Hero Award by Chapter 38 of the Disabled American Veterans on June 11, 2016 WHEREAS. Members of the Armed Services from the State of New York, who have served so valiantly and honorably in wars in which this country's freedom was at stake, as well as in the preservation of peace in peacetime, deserve a special salute from this Legislative Body and the people of the State of New York; and WHEREAS, This Legislative Body is justly proud to commend veteran Brigadier General Richard Butterfield upon the occasion of his designation as the third recipient of The Rev. Francis A. Kelley Home Town Hero Award by Chapter 38 of the Disabled American Veterans to be celebrated on Saturday, June 11, 2016, at the East Greenbush YMCA; and WHEREAS, Brigadier General Richard L. Butterfield has exhibited his patriotism both at home and abroad, demonstrating his love for his country and meriting forevermore, the highest respect of his State and Nation; and WHEREAS, Brigadier General Richard L. Butterfield served his country as a member of the United States Army from 1963 -1970, and the New York Army National Guard from 1970 to 1995; and WHEREAS, While on active duty, he served as a Second Lieutenant with the 11th Pathfinders 1st Cavalry Division, 1965 to 1966; in this position, he was in the battle at LZ X-Ray where both sides suffered heavy casualties; the United States had nearly 250 soldiers killed but claimed to have counted about 1,000 North Vietnamese bodies on the battlefield and estimated more were killed by air strikes and artillery; and WHEREAS, Lieutenant Butterfield and his team were responsible for the resupply and medical evacuation missions for the battle; after this battle was over, some of the unit walked out to LZ Columbus, after arriving there after dark, it was learned that the 2nd Battalion 7th Cavalry had been ambushed while marching to LZ Albany; of the roughly 400 soldiers in the Battalion, 70% were killed or wounded; and WHEREAS, A night time rescue mission was launched to evacuate the wounded and Lieutenant Butterfield led the pathfinder team to LZ Albany on this mission; and WHEREAS, After air assaulting in, Lieutenant Butterfield's team ran medevac missions all night and into the next morning making sure all wounded were removed: around 1:00 a.m. Lieutenent Butterfield was wounded and did not leave his team until all other wounded soldiers were removed from the battlefield: and WHEREAS, Captain Butterfield served a second tour in Viet Nam in 1968 as company commander of E company 2nd Battalion 506 Inf. 101st Airborne; his company conducted many combat operations inflicting heavy casualties on the enemy; and WHEREAS, After recovering from injuries at Camp Zama, Japan, Captain Butterfield returned to Viet Nam and served with the 5th Special Forces Group Airborne assigned to Command and Control South Special

Operations Group; missions from this unit were classified; and WHEREAS, After serving on active duty, Captain Butterfield served the New York Army National Guard serving as a company commander, Battalion Commander 2nd of the 105th Infantry and as the commander of the 1st Brigade 42nd Infantry Division; and WHEREAS, Brigadier General Richard L. Butterfield served with the New York State Police from February 1970 until 2006; currently, he serves with the Warren County Sheriff's office with the Narcotics Enforcement Unit and is cross designated to the New York State Police; and WHEREAS, Brigadier General Richard L. Butterfield has 28 persona I awards and decorations with the Purple Heart being his most cherished; and WHEREAS, Residents of this great State must never forget the courage with which these men and women served their country, and must recognize that no greater debt is owed than that owed to those who gave their lives for their beloved Nation and to those who continue to be missing in action; and WHEREAS, Having exhibited his patriotism both at home and abroad, Brigadier General Richard L. Butterfield demonstrated his love for his country and merits forevermore, the highest respect of his State and Nation; and WHEREAS, Our Nation's veterans deserve to be recognized, commended and thanked by the people of the State of New York for their service and for their dedication to their communities, their State and their Nation; now, therefore, be it RESOLVED, That this Legislative Body pause in its deliberations to commend veteran Brigadier General Richard L. Bill to honor fallen North Country state trooper passes state assembly (reproduced and edited)

A bill that would rename bridges crossing the Saranac River on I-87 in memory of a state trooper who died from illness in the aftermath of 9/11 has passed the New York State Assembly. Brian S. Falb was stationed in Troop B in 1998 and remained there for 18 years. During the attacks at the Twin Towers, Falb was assigned to help in the search and recovery efforts in New York City. In March of 2017, he died from cancer that stemmed from his time assigned at the attack site.The State Assembly passed a bill on Monday that approved the bridges' name changes in Falb's memory. "The North Country

lost a true hero with the passing of Trooper Falb, and it was my honor to ensure that his memory lasts forever by adding his name to the bridges over the Saranac River," Assemblyperson Billy Jones (D-Chateaugay Lake), who sponsored the bill, said in a press release. "He gave the ultimate sacrifice during our country's time of need, and I am proud to join the community in showing our gratitude and appreciation for his service by renaming these bridges in his honor." Town of Plattsburgh Supervisor Michael Cashman said it was important for the town to honor Falb's legacy. "Trooper Falb was a dedicated public servant and member of the Town of Plattsburgh community, and it was important to all of us that the Town honor his legacy," he said in the release. A similar bill sponsored by Sen. Dan Stec (R,C-Queensbury) also passed the state Senate. It now waits for Gov. Kathy Hochul's signature to become law. "He lost his life in the line of service after working as part of the search and recovery efforts on 9/11. I'm glad we can acknowledge his heroism and show gratitude for all he did by renaming the twin bridges over the Saranac in his honor."
